The commercial information contained on the website does not constitute an offer within the meaning of the Civil Code, but is an invitation to tender.

The technical condition required of the customer is access to a computer with Internet access.

1. Terms of the order

- a. A condition of making the order is for the customer to register and log in to the store, add selected products to the cart, and confirm the order.
- b. The contract of sale is concluded upon receipt by the customer of the confirmation of the order from the online store.
- c. If the goods are absent from the warehouse, the customer is informed of both this fact and a possible extension of the term of the contract. In this case, the customer may agree to extend the term, and cancel either the entire order or the product that would extend the duration of the contract.
- d. In the case of goods marked with an X, i.e. publications prepared specifically at the customer's request, the term of the contract may take up to 3 weeks.

2. Product prices

4. Delivery

- b) The customer may cancel the contract by submitting a declaration of withdrawal from the contract. - c) The postage costs of the return of goods shall be borne by the customer. Returned goods should be returned adequately protected, with the accompanying proof of purchase (VAT invoice or fiscal receipt). 6. Refunds
